Tuesday, October 4, 2022

Pursuant to the law, the Atchison County Commission Board met in Regular Session at 1:00 PM at the Atchison County Courthouse, Lower Level, 423 N 5th St., Atchison, KS. A link to the meeting was made available to the public prior to the meeting. In addition, public attendance was available for the Commission meeting at the Atchison County Courthouse, Lower Level, 423 N 5th St., Atchison, KS. Chairman Eric Noll, called the meeting to order with Commission Casey Quinn and County Counselor Patrick Henderson present for the meeting. Commissioner Jack Bower was absent. Kalee Vanderweide, Deputy County Election Officer recorded the minutes.

The Board recited the pledge of allegiance to start the meeting.

*Public Comment:

There were none.

*Reading and Approval of Minutes:

Chairman Noll tabled the approval of minutes to next week.

*Commissioner Comments and Committee Reports:

Chairman Noll stated that the Board met with several Joint Communication Board members and had a very good discussion.

*New Business Before the Board:

Chairman Noll presented two applications for license to sell cereal malt beverages submitted by Robert Urton for Potter Liquor, LLC. The first was an application for a license to sell cereal malt beverages for consumption on the premises. The second was an application for a license to see cereal malt beverages in original and unopened containers and not for consumption on the licensed premises. Commissioner Quinn made a motion to approve the two CMB license applications. Chairman Noll seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 2-0.

Chairman Noll presented an additional 2023 Budget form that District Court had requested be signed and sent to the State. The Chairman just needed to sign the form, since the budget had already been approved. Chairman Noll signed the form as requested.

Chairman Noll presented an additional 2023 Budget form that Atchison County Extension had requested to be signed. The Chairman just needed to sign the form, since the budget had already been approved. Chairman Noll signed the form as requested.

Chairman Noll presented a letter provided by Connie Ellerman, County Treasurer and Mark Zeltner, Finance Director; to alter the County Wide Sales Tax Percentage

Allocation, with 40% to the Solid Waste Fund 202 and 60% to the Joint Communication Fund 205. Commissioner Quinn made a motion to approve the new allocation of County Wide Sales Tax Percentage. Chairman Noll seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 2-0.

*County Counselor Updates:

Patrick Henderson, County Counselor introduced a Property Damage Settlement and Release form, related to damage to Bridge No. C.O-3.5 on 222nd Road near Arrington. The bridge was severely damaged on or about November 9, 2021, when a truck hauling large rocks crossed the bridge. The Bridge was repaired by the Road & Bridge Department. Superintendent Joe Snyder calculated that the cost of the repair was \$11,237.74, including manpower, equipment usage, and materials. Continental Western Group agreed to make the payment on behalf of the contractor. Commissioner Quinn made a motion to approve the Chairman signing the Property Damage Settlement and Release form, and receiving a check for \$11,237.74. Chairman Noll seconded the motion. Chairman Noll seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 2-0.

Counselor Henderson stated the tax sale is tomorrow, Wednesday, October 5,2022 at 10:00 am.

*Executive Session:

Commissioner Quinn moved that the Board of County Commissioners recess into executive session at 1:10 pm to discuss personnel matters of nonelected personnel, as allowed by K.S.A. 75-4319(b) (1), and that the purpose of the closed session is to protect the privacy rights of the employee, and that the Board come out of the executive session at 1:25 pm, in the commission room, courthouse basement. Those present will be: the three commissioners, County Counselor Patrick Henderson, and HR Director Jodi Moore. Chairman Noll seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 2-0.

There was no action taken during the executive session.

*Public Comment:

There were no public comments.

Bills were presented to be signed.

Commissioner Quinn made the motion to adjourn at 1:25 pm. Chairman Noll seconded the motion. Chairman Noll called for a vote, all voted aye. The motion passed 2-0.
