

RESOLUTION NO. 1116  
ORGANIZATIONAL MEETING FOR 1994

WHEREAS, the Board of County Commissioners of Atchison County, Kansas has determined that it shall annually formalize by Resolution certain items from it's organization meeting;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSION OF ATCHISON COUNTY, KANSAS, that meetings of the Board shall continue to be regularly held at 9:30 A.M. on Monday, Wednesday and Friday of each and every week, unless cancelled or a meeting is called for said day at a different time. Said meetings shall conclude at Noon unless the Board determines that the meeting shall be concluded after having considered all business.

BE IT FURTHER RESOLVED that the County Clerk shall maintain tapes of said meetings which shall be accessible to the public for 7 days after each meeting. The County Clerk may reuse said tapes for recording of subsequent meetings thereafter.

BE IT FURTHER RESOLVED that Department Heads shall submit any business they have for the Board between 9:30 A.M. and 10:30 A.M. at the Board's regular meetings.

BE IT FURTHER RESOLVED that any Agenda items shall be submitted to the County Clerk's office by 5:00 P.M. of the business day prior to the regular meeting in order to appear on the Commission's Agenda for consideration;

BE IT FURTHER RESOLVED that the Court House bad weather policy is that in the event inclement weather may affect the ability of Court House county employees to come to or remain at work, the department head of each department shall have the discretion to allow any employee to take a vacation day or personal day available to said employee to allow the employee's absence from work. The Board of County Commissioners reserves the sole right to determine whether or not the Court House shall be closed for any reason.
