

RESOLUTION NO. 1134

A RESOLUTION DESIGNATING A REVITALIZATION AREA FOR
ATCHISON COUNTY, KANSAS

WHEREAS, Atchison County, Kansas (the "County"), desires to establish a Neighborhood Revitalization Plan as required by the 1994 Kansas Session Laws Chapter 242; and,

WHEREAS, The Board of County Commissioners of Atchison County, Kansas, pursuant to notice of public hearing, did hold a public hearing on April 17, 1995, to hear and consider public comment on the Neighborhood Revitalization Plan as required by 1994 Kansas Session Laws Chapter 242; and,

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ATCHISON COUNTY, KANSAS:

Pursuant to 1994 Kansas Session Laws Chapter 242 Section 12 the Board of County Commissioners of Atchison County, Kansas hereby designates the following described property as a neighborhood revitalization area and find that the area contains:

1. A predominance of buildings which by reason of dilapidation are detrimental to the public health, safety, and welfare in its present condition and uses.
2. A substantial number of deteriorating structures which impair sound growth of the County and retards provisions of housing accommodations.
3. A predominance of buildings which are significant and should be restored to productive use.

Neighborhood revitalization area is designated as follows:

Beginning at a point in the Northwest Corner of Section Six, Township Five (5) South, Range Seventeen (17) East, thence South along the West side of Range Seventeen (17) East to the Southwest corner of Section Thirty one (31), Township Five (5) South, Range Seventeen (17) East; thence West to the Northwest corner of Section Six (6), Township Six (6) South, Range Seventeen (17) East, thence South to the Southwest corner of Section Nineteen (19), Township Seven (7) South, Range Seventeen (17) East, thence East to the Southeast corner of Section Twenty (20), Township Seven (7) South, Range Twenty-Two (22) East thence East to the Missouri River, thence in a Northerly direction following the Missouri River to the point of intersection of the Missouri River and the North Section line of Section Four (4), Township Fifty-five (55) North, Range Thirty-seven (37) West, thence West along the north line of Township Fifty-five (55)

North and crossing Section Seventeen (17), Township Five (5) South, Range Twenty-one (21) East to the point of intersection with the course of Independence Creek, Thence in a Northwesterly direction following the course of Independence Creek to the point of intersection with the east line of Section One (1), Township Five (5) South, Range Twenty (20) East, thence North to the Northeast corner of Section One (1), Township Five (5) South, Range Twenty (20) East, thence west to the northwest corner of Section Six (6), Township Five (5) South, Range Seventeen (17) East to the point of beginning.

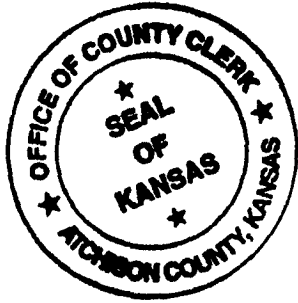
