

RESOLUTION NO. 1191

A RESOLUTION OF THE COUNTY OF ATCHISON, KANSAS, STATING COMMITMENT TO SEEK FUNDING THROUGH THE KANSAS DEPARTMENT OF COMMERCE & HOUSING, SMALL CITIES CDBG PROGRAM, IN THE AMOUNT OF \$257,360 AND FURTHER COMMITMENT, BY THE COUNTY, TO LEVERAGE PROJECT COSTS IN THE AMOUNT OF \$12,000 BY DONATION OF LAND FOR THE BUILDING SITES FROM THE CITY OF HURON (\$3,700) AND THE CITY OF LANCASTER (\$8,300) WITHIN ATCHISON COUNTY, KANSAS.

WHEREAS, Title 1 of the Housing and Community Act does state as its primary objective, "The development of viable urban communities, by providing decent housing and suitable living environment and expanding opportunities, principally for persons of low/moderate income."

WHEREAS, Title 1 does offer to communities the opportunity of monetary assistance in accomplishing its stated primary objective with a Community Development Block Grant; and,

WHEREAS, THE KANSAS DEPARTMENT OF COMMERCE AND HOUSING is designated to award Community Development Block Grants under Title 1; and,

WHEREAS, The County of Atchison, Kansas, does have areas of need which may be addressed through the Community Development Block Grant Program.

WHEREAS, the County of Atchison, Kansas, intends to submit a grant application for funding of construction of two (2) fire houses for Fire District #5, one in the City of Huron, Kansas and one in the City of Lancaster, Kansas through the Community Development Block Grant Program.


NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY OF ATCHISON, KANSAS:

1. The total project cost of the proposed project is \$269,360. The County intends to request a grant of \$257,360 through the CDBG Program. The remaining cost will be provided through local matching funds in the amount of \$12,000 by donation of land for the building sites from the City of Huron (\$3,700) and the City of Lancaster (\$8,300) within Atchison County, Kansas.


2. The Chairman is authorized to prepare and submit documents, which are necessary in applying for funding and establishing an Administrative Organization to implement activities pursuant to the aforementioned act.
