ATCHISON COUNTY RESOLUTION NO. 2023- 1517

**A RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF
ATCHISON COUNTY, KANSAS DESIGNATING ELM DRIVE AS A
TOWNSHIP OR LOCAL SERVICE ROAD PURSUANT TO K.S.A. 68-
506(a)(4) AND INCLUDING SAID ROAD IN THE COUNTY ROAD SYSTEM**

WHEREAS, Joseph P. Hansen and Denita F. Hansen have submitted a preliminary plat to effectively divide their current property into two individual lots, which was approved by the City of Atchison Planning & Zoning Commission on June 3, 2020, as part of the City's extraterritorial subdivision jurisdiction under K.S.A. 12-754; and

WHEREAS, Joseph P. Hansen, Denita F. Hansen, Jeremiah J. Wilburn, Geri L Wilburn, Robert E. Downey, Sandra S. Downey, Lyle E. Bowen, Lydia L Bowen, Timothy W. Stafford and Vicki L Stafford have executed a PLAT DEDICATION as part of the ELMVIEW subdivision, and

WHEREAS, the Board of County Commissioners accepted the PLAT DEDICATION as evidenced by their approval of the PLAT on September 28, 2021; and

WHEREAS, the said PLAT was recorded in the office of the Register of Deeds as SLIDE-C200 on November 2, 2021; and

WHEREAS, the PLAT DEDICATION within said PLAT includes a dedication of Elm Drive located in the Northwest Quarter of Section 12, Township 6 South, Range 20 East of the 6th P.M., and Elm Drive is proposed to be added to the County road system; and

NOW THEREFORE, BE IT RESOLVED:

1. Elm Drive, as described in the PLAT DEDICATION of the PLAT recorded in the office of the Register of Deeds as SLIDE-C200 on November 2, 2021 is hereby accepted into the Atchison County Road System.

2. Elm Drive is designated as a Township or Local Service Road as mentioned in K.S.A. 68-506(a)(4).

3. Elm Drive shall be maintained by Shannon Township.

THIS RESOLUTION shall become effective upon publication once in the official County newspaper.
