

**INTERLOCAL COOPERATION AGREEMENT
RELATING TO ADMINISTRATION OF NEIGHBORHOOD REVITALIZATION PLANS
FOR TAXING DISTRICTS WITHIN ATCHISON COUNTY, KANSAS
RESOLUTION NO. 2013-1378**

This Agreement made and entered into as of the 28th day of October, 2013, by and between the County of Atchison , State of Kansas, a Municipal Corporation, herein called “County”, and the following municipalities as defined in K.S.A. 10-1101 and the amendments thereto, all of which are located , in whole or in part, in Atchison County, Kansas, to wit.

CITIES: Atchison, Effingham, Huron, and Muscotah

TOWNSHIPS: Benton, Grasshopper

UNIFIED SCHOOL
DISTRICTS: U.S.D 409, Atchison; U.S.D 377, Effingham

All of whom will be collectively referred to herein as “MUNICIPALITIES”

WITNESSETH:

Whereas, Each and all of the parties hereto is a “municipality” as the term is defines in K.S.A. 10-1101 and each and all of the parties hereto has adopted a revitalization Plan as authorized and provided under the Kansas Neighborhood Revitalization Act as set forth in K.S.A. 1994 Sup. 12-17,114 et seq.; and

Whereas, K.S.A., 1994 Sup., 12-17-119 specifically authorizes two or more municipalities to cooperate with each other in the administration of Revitalization Plans adopted by them provided in the Interlocal Cooperation Act as set forth in K.S.A. 12-2901 et seq.;

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS CONTAINED HEREIN, THE PARTIES AGREE AS FOLLOWS:

1. The parties agree to consider and adopt a neighborhood revitalization plan. The parties further agree the neighborhood revitalization plan as adopted will not be amended by any of the parties except as may be necessary to comply with the applicable State law or regulation.
2. The parties further agree that the County shall administer the neighborhood revitalization plan as adopted by each party behalf of the signatory parties. The parties acknowledge and agree that five (5) per cent of increment, as defined by S.B. 732, shall be used to pay for administrative cost of the County implementing and administering the plan, all as described in the neighborhood revitalization find as defined in section 14 of A.B. 732.
3. This Agreement shall expire October 31, 2021. The parties agree to undertake review of the neighborhood revitalization plan commencing May 1, 2021 to determine continuation of a neighborhood revitalization plan and participation in a new agreement.
4. Terms and provisions of this agreement shall be in full force and effect November 1, 2013.

IN WITNESS WHEREOF, the parties have hereunto caused this agreement to be duly executed by their officers duly authorized as of the day and date first above written such execution by being completed in counter-parts, each of which is executed by the COUNTY, equal in number to the total number of parties to this agreement and the original of which, as fully executed by all parties herto, shall be filed in the office of the County Clerk, Atchison County, Kansas, for the use and benefit of all parties.

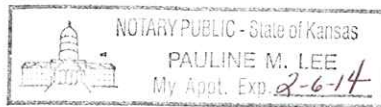

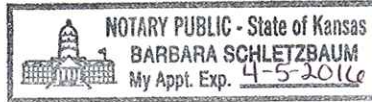

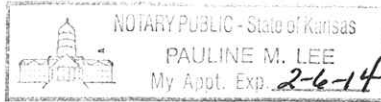
