**A RESOLUTION OF THE BOARD OF
COUNTY COMMISSIONERS OF ATCHISON COUNTY, KANSAS,
AUTHORIZING THE VACATION OF A PORTION OF ROAD LOCATED
IN AN UNINCORPORATED PORTION OF ATCHISON COUNTY, KANSAS**

This Resolution is made and entered into this 19th day of August, 2014, by the Board of County Commissioners of Atchison County, Kansas.

WHEREAS, at a regular meeting of the Board of County Commissioners of Atchison County, Kansas held on Tuesday, August 12, 2011, there came before the Board for consideration the Petition of Albert Hale and Jason Roloff requesting vacation a road situate in Atchison County, Kansas; and

WHEREAS, K.S.A. 68-102. *et seq.*, provides the Board with a method to vacate certain roads; and

WHEREAS, pursuant to the guidelines of these state statutes, the Board received a petition from Albert Hale and Jason Roloff requesting vacation a road situate in Atchison County, Kansas, being the owners of all the land adjacent to said road, to-wit:

Between the Southwest and Southeast Quarter Sections of Section 8, Township 6 South, Range 20 East, starting at the southernmost point of Section 8 going north and joining county road 274

WHEREAS, on this date, pursuant to K.S.A. 68-102a, the Board held a public hearing to consider the requested vacation; and

WHEREAS, at that public hearing, the Board was satisfied that due and regular published notice had been given at least twenty days prior to the hearing date as required; and

WHEREAS, the Board determined that the public would suffer no loss or inconvenience by the requested vacation and that no private rights will be injured or endangered thereby; and

IT IS NOW, THEREFORE, HEREBY ORDERED AND RESOLVED by the Board of County Commissioners of Atchison County, Kansas, that the road located between the Southwest and Southeast Quarter Sections of Section 8, Township 6, Range 20,

starting at the southernmost point going north and joining county road 274 is hereby vacated.

IT IS FURTHER ORDERED THAT the vacation of said portion of road is subject to the reservation of any currently existing easements for public utilities over, under, and across all that portion of vacated road for the repair, maintenance, and replacement of any existing utilities presently located within the vacated road.

IT IS FURTHER ORDERED THAT a copy of this resolution shall be forwarded to the County Clerk to be placed in the road records.

IT IS FURTHER ORDERED that a copy of this resolution shall be forwarded to the County Appraiser.

IT IS FURTHER ORDERED that this Resolution shall take effect after its publication in the official County newspaper.

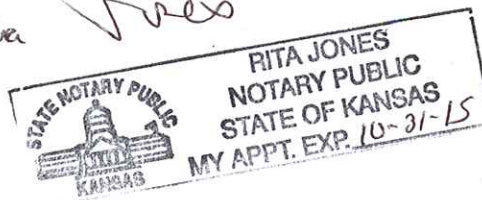
