**A RESOLUTION OF BOARD OF COUNTY COMMISSIONERS
OF ATCHISON COUNTY, KANSAS DESIGNATING MORTON ROAD
BETWEEN U.S. HIGHWAY 59 AND 238th ROAD AS A COUNTY MAJOR
COLLECTOR ROAD PURSUANT TO K.S.A. 68-506(a)(2) AND
INCLUDING SAID ROAD IN THE COUNTY ROAD SYSTEM**

WHEREAS, 238th Road between McPherson Road on the West and U.S. Highway 59 on the East is a County Major Collector Road included within the County road system; and

WHEREAS, the bridge on 238th Road over Camp Creek just west of U.S. Highway 59 is in a state of disrepair; and

WHEREAS, traffic on 238th Road could easily be rerouted over Morton Road between 238th Road on the North and U.S. Highway 59 on the South to avoid travel over said bridge; and

WHEREAS, Morton Road is currently maintained by Mount Pleasant Township;


NOW THEREFORE, BE IT RESOLVED:

1. Morton Road between 238th Road on the North and U.S. Highway 59 on the South is hereby designated as a County Major Collector Road.

THIS RESOLUTION shall become effective upon publication once in the official County newspaper.

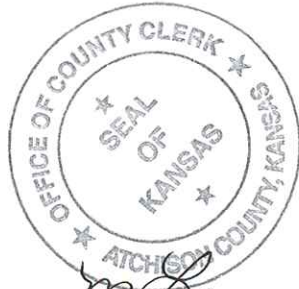
