

Resolution No. 2018-1433

**RESOLUTION DECLARING CERTAIN ROADS
WITHIN ATCHISON COUNTY AS MINIMUM MAINTENANCE ROADS
PURSUANT TO K.S.A. 68-5,102**

WHEREAS, the Township Boards of Kapioma Township, Mt. Pleasant Township, and Walnut Township, all located within Atchison County, Kansas, recommended that the Board of County Commissioners declare certain roads within their respective townships to be minimum maintenance roads; and

WHEREAS, upon receipt of said requests, the Board of County Commissioners followed the procedure set for under K.S.A. 68-5,102 for determining whether roads should be designated as minimum maintenance roads, and

WHEREAS, on December 26, 2017 the Board of County Commissioners adopted Resolution No. 2017-1431, a RESOLUTION COMMENCING PROCEEDINGS TO DECLARE CERTAIN ROADS WITHIN ATCHISON COUNTY AS MINIMUM MAINTENANCE ROADS; and

WHEREAS, notice of a public hearing was published in the Atchison Globe on Saturday, December 30, 2017 and

WHEREAS, on the 23rd day of January, 2018 at 1:30 o'clock p.m, the Board of County Commissioners held a public hearing for the purpose of hearing evidence and testimony of all interested persons considering whether the subject roads should be declared to be minimum maintenance roads; and

WHEREAS, the Board of County Commissioners has considered whether the subject roads should be declared to be minimum maintenance roads;

NOW, THEREFORE, BE IT RESOLVED that the following township roads are used only occasionally or are used only by a few individuals, and that the same are declared "minimum maintenance roads," to-wit:

Kapioma Township:

270th Road from Allen Road to Anderson Road.

270th Road from Bourbon Road to Chautauqua Road.

Allen Road from 254th Road to 262nd Road.

Anderson Road from 254th Road South to 246th Road.

Anderson Road from 246th Road South to a point 400 feet South of the centerline of Section 32-7-17.

246th Road from Anderson Road East to the Delaware River

242nd Road from Barton Road to Bourbon Road.

Barton Road from 242nd Road south one mile to the center section line of 4-7-17.

Cheyenne Road from 262nd Road to 254th Road.
246th Road from Chautauqua Road to Cheyenne Road.
238th Road from Allen Road to Anderson Road.
238th Road from Cheyenne Road to Chautauqua Road.
238th Road from Bourbon Road to a point 210 feet west of the center of Chautauqua Road.
238th Road from Barton Road East for 1,925 feet.
Clay Road from 270th Road South 2,130 feet.
Clay Road from State Highway 116 to 238th Road.
Anderson Road from State Highway 116 to 214th Road.
214th Road from Barton Road to a point 1,940 feet west of Anderson Road.
Bourbon Road from a point 435 feet south of State Highway 116 to 206th Road.
210th Road from Barton Road East to the end of the dedicated roadway.
222nd Road from Barton Road East to a point 2,710 feet east of Bourbon Road.
222nd Road from Chautauqua Road to a point 665 feet West of Cheyenne Road.
214th Road from Bourbon Road to a point 2,720 feet east of Chautauqua Road.
Chautauqua Road from a point 2,500 feet north of 214th Road to a point 1,860 feet south of 214th Road.

Mt. Pleasant Township:

Osage Road from 2000 feet south of the north line of Section 17 T6S R20E North to the North line of Section 17 T6S R20E.
254th Road from Osage Road to Osborne Road.
246th Road from Neosho Road to US Highway 59.
246th Road from Osage Road to US Highway 59.
246th Road from Osage Road to Osborne Road.
246th Road from Osborne Road to Ottawa Road.
246th Road from 300 feet east of Ottawa Road to the end approximately one quarter of a mile.
226th Road from 230th Road 840 feet east of the NE corner of Section 8 T76S R20E southwesterly for approximately one mile.
226th Road from 1100 feet east of Neosho Road east to its termination for approximately 500 feet.
Neosho Road from 1320 feet south of 226th Road South for one mile.
Nemaha Road from the North line of Section 18 T7S R20E South for 4480 feet.
Phillips Road from 230th Road South to Ottawa Road.
234th Road from Rawlins Road near the east centerline of Section 2 T7S R20E West for approximately 2000 feet.
Rooks Road from 234th Road at the center of Section 1 T76S R20E South for approximately one quarter of a mile.

Rooks Road from 475 feet South of 234th Road at the east center of Section 1 T76S R20E South approximately 4500 feet.
226th Road from Rawlins Road East to the center of Section 12 T76S R20E then north approximately one quarter of a mile.
Rush Street from 210th Road to 2nd Street in Bennett Springs Subdivision.

Walnut Township:


222nd Road from Trego Road east.
Trego Road from 210th Road north.
218th Road from Rooks Road to Sheridan Road.


BE IT FURTHER RESOLVED that within ten (10) days of adoption of this Resolution, signs shall be posted on said roads stating "Minimum maintenance" and "travel at your own risk." Such signs shall display black letters on a yellow background with the letters being at least two inches high.

BE IT FINALLY RESOLVED that this resolution shall be effective upon publication in The Atchison Globe.
