**JOINT RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF
ATCHISON COUNTY, KANSAS AND THE CITY OF ATCHISON,
KANSAS, IN SUPPORT OF THE PROPOSED 911 SERVICE
AGREEMENT BETWEEN MID-AMERICA REGIONAL COUNCIL AND
THE ATCHISON COUNTY COMMUNICATIONS BOARD.**

WHEREAS, the Board of County Commissioners of Atchison County, Kansas and the City of Atchison, Kansas have previously entered into an agreement providing for the establishment and operation of the Atchison County Communications Board (Atchison County Resolution Number 2014-1390 and City of Atchison Ordinance Number 6472); and

WHEREAS, the Atchison County Communications Board has recommended that Atchison County join the complex enhanced Regional 911 System sponsored by the Mid-America Regional Council (hereinafter "MARC") and operated by their Public Safety Communications Board; and

WHEREAS, MARC'S Public Safety Communications Board has proposed the execution of a written agreement entitled 911 Service Agreement Between Mid-America Regional Council And Atchison County, Kansas Joint Communications Board, a copy of which is attached hereto; and

WHEREAS, under the terms of said agreement MARC will take ownership of certain equipment used to deliver enhanced 911 services in Atchison County, Kansas; and

WHEREAS, both the Board of County Commissioners of Atchison County, Kansas and the City of Atchison, Kansas currently have an ownership interest in and to said equipment, which ownership will be forego upon execution of the proposed agreement by the Atchison County Communications Board;

BE IT THEREFORE RESOLVED by the Board of County Commissioners of Atchison County, Kansas and by the Governing Body of the City Of Atchison, Kansas that the Atchison County Communications Board is authorized and encouraged to execute the proposed 911 Service Agreement Between Mid-America Regional Council And Atchison County, Kansas Joint Communications Board agreement.


This Resolution shall be effective upon adoption by both the Board of County Commissioners of Atchison County, Kansas and the City of Atchison, Kansas.


