

RESOLUTION NO. 1122

A RESOLUTION PURSUANT TO THE PROVISIONS OF K.S.A. 1993 SUPP.. 19-1930 (d) PROVIDING FOR PAYMENTS BY INMATES TO DEFRAY MAINTENANCE COSTS.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ATCHISON COUNTY:

Section 1. Any inmate of the Atchison County Jail who participates in a work release or job training program for which the inmate receives compensation or a subsistence allowance shall be required to pay to the county an amount of \$10.00 per day to defray costs of maintaining such inmate in the county jail.

Section 2. The requirement of payment of this per diem can be reduced or such amount can be waived in instances in which payment would create undue hardship for an inmate. Such a determination of reduction or waiver and the determination of undue hardship for the inmate shall be made by the Board of County Commissioners of Atchison County upon application by the inmate and a recommendation endorsed by both the Atchison County Sheriff and the Court Services Officer.

Section 3. The inmate shall pay the amount due in cash or by money order to the county treasurer. The county treasurer shall deposit the entire amount in the county treasury and credit it to the county general fund. The county treasurer shall issue a receipt to the inmate after which the inmate shall deliver the receipt to the Sheriff's Department Administrative Secretary/Records Clerk. After the Sheriff's Department Administrative Secretary/Records Clerk has posted said receipt, the receipt shall be returned to the inmate. Payment shall be made at intervals established by the Atchison County Sheriff's Office. Timely payments made pursuant to the Sheriff's Department schedule shall be a condition of the inmates work release. Failure by the inmate to make timely payments shall subject the inmate to termination of the work release. No inmate shall be eligible for release until the amount required pursuant to Section 1 is paid in full.

Section 4. If payment is made in cash, the county treasurer shall provide the inmate with a written receipt for such payment.

Section 5. If Atchison County is otherwise entitled to receive reimbursement or compensation for the maintenance of the inmate who is required to pay an amount pursuant to this resolution, the amount paid by such inmate shall be deducted from the amount of other reimbursement or compensation to which Atchison County is entitled.

Section 6. This resolution is adopted pursuant to K.S.A. 1993 SUPP.. 19-1930 (d).

Section 7. This resolution shall become effective upon the date of adoption.
