

**RESOLUTION CONCERNING COUNTRY CLUB ROAD ADJACENT TO THE
ATCHISON SPORTS COMPLEX; NOTIFYING THE CITY OF ATCHISON, KANSAS
OF ROAD WITH COMMON BOUNDARY OF CITY AND CONSENTING TO
ANNEXATION**

RESOLUTION NO. 1322

WHEREAS, the county road commonly known as Country Club Road near the ATCHISON SPORTS COMPLEX has common boundary lines on both the north and south with the City of Atchison, but said road is not currently a part of the City of Atchison; and


WHEREAS, the legal description of said roadway is as follows:


A TRACT OF LAND IN THE SOUTHWEST QUARTER AND THE NORTHWEST QUARTER OF SECTION 35, AND THE SOUTHEAST QUARTER AND THE NORTHEAST QUARTER OF SECTION 34, TOWNSHIP 5 SOUTH, RANGE 20 EAST OF THE 6TH PRINCIPAL MERIDIAN, ATCHISON COUNTY, KANSAS DESCRIBED AS FOLLOWS: ALL OF THE RIGHT-OF-WAY OF COUNTRY CLUB ROAD NOT PREVIOUSLY ANNEXED IN TO THE CITY OF ATCHISON BETWEEN THE WEST RIGHT OF WAY LINE OF GRANDEUR ROAD AND THE WEST RIGHT-OF-WAY LINE OF 17TH STREET;

NOW THEREFORE; the Board of County Commissioners of Atchison County, Kansas, pursuant to K.S.A. 12-520 (f), hereby notifies the governing body of the City of Atchison, Kansas, of the existence of such road which is not currently a part of the city but which has a common boundary with the city, and consents to annexation of such road by the City of Atchison, Kansas.

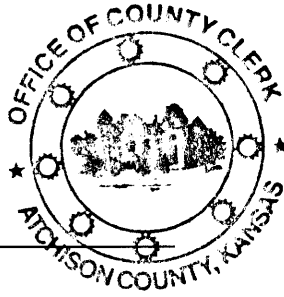

A TRACT OF LAND IN THE SOUTHWEST QUARTER AND THE NORTHWEST QUARTER OF SECTION 35 AND THE SOUTHEAST QUARTER AND THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 5 SOUTH, RANGE 20 EAST OF THE PRINCIPAL MERIDIAN, ATCHISON COUNTY, KANSAS DESCRIBED AS FOLLOWS: ALL OF THE RIGHT-OF-WAY OF COUNTRY CLUB ROAD NOT PREVIOUSLY ANNEXED BETWEEN THE WEST RIGHT-OF-WAY LINE OF GRANDEUR ROAD AND THE WEST RIGHT-OF-WAY LINE OF 17TH STREET.
